

# TECHMOUNT P/N 4-10105 kit



The StemMount is designed to snugly fit into the steering stem hole, in the top triple clamp assembly. If your bike has a rubber plug in this hole, it must be removed.

The mount system can be easily converted to fit many different bikes by removing the o-ring post and installing any of the other sizes (see chart below for correct size) that fits your bike.

1. Dampen the o-ring post that fits your bike with provided moist towelette. (Once dry it will be firmly in place.)
2. Hold the Stem Mount firmly and press and rotate the mount into the top of your steering stem hole until the base of the Stem Mount touches the stem nut.
3. Install the optional top adapter for your device and tighten the locking ring so that it is at desired angle.

The Stem Mount is removed by pulling upward firmly while rotating slowly.

The warranties set forth herein apply only to the original customer and are conditional upon the customer giving prompt notice to High Gear of any discovered defects during the Warranty Period.
